- 1. Call to Order by Mayor Nelson @ 3:40pm.
- 2. Roll Call by Sandra Herring.
- 3. Certify Posting in accordance with State Law.
- 4. Invocation & Pledge by Cecil Sparks and Billie Jean Scaggs.
- 5. Discussion concerning water system improvements with engineer.

KSA Engineers was represented by Stephen Dorman, Brent Bassett and Stuart Cowell. Brent Bassett explained, as part of the Comprehensive Performance Evaluation and the Direct Integrity Test that the water plant failed that testing. Issues failing were membrane filters and fiber replacement as well as air and water pressures within the plant. KSA expressed that the City needed to contract with Koch Membrane for the maintenance of the plant. Mr. McDonald explained that the research of that agreement was more channeled to the Scada maintenance and tech support and not the physical maintenance of the plant and the city should enter agreement with Koch for technical support minimum twice-a-year visit and Aqua-Claire Technologies for maintenance support. Mr. McDonald contacted and research another option utilized by the City of Temple and they come highly recommended. It is a Texas firm and there will be less charges involved in travel and time leaving additional funds for repairs. Council questioned KSA about the line on Southland and Agarita and how that line was not discovered in their research for the TWDB Funding. Council expressed to KSA that there were no lines in South Marlin schedules to be completed on this round of funding. KSA expressed that the lines were identified based on the severity of the leak issues and the amount of water leaking from the lines and put in a priority order. KSA presented a power point presentation as a result of the meter study. They expressed that over half of the water meters were either leaking, defective, old and not legible or actually running backwards resulting in negative meter readings. Replacing the meters that

have been identified with new auto read meters and adding the auto read to the other meters would increase the revenue for the city and take less man hours to do the meter readings each month. Council discussed an additional review of the project.

6. Discussion of personnel policy.

There was no discussion on this item.

7. Budget Discussion.

Council and Mr. McDonald discussed a few areas of the budget that are expected to be a short fall for the city that included Fire Reimbursement, Citation Revenue and Water and Sewer Revenue resulting from the water issues we have experienced this fiscal year.

Adjourn.
