

ORDINANCE No. 18-020

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARLIN, TEXAS, AMENDING THE SOLID WASTE COLLECTION RATES ON RESIDENTIAL, COMMERCIAL, AND INDUSTRIAL; IMPLEMENTING THE NEW RATES AS SHOWN.

WHEREAS, the solid waste collection company has not had a rate increase since November of 2013; and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and City Council of the City of Marlin, Texas to change the Solid Waste Rates as shown below:

Fuel surcharge fee billed per contract and extra dump and roll-off container charges per rate sheet.

Section 2. That the rates of this ordinance shall be assessed for all services billed on or after October 1, 2018.

Section 3. That all parts of Ordinance in conflict with the provisions of this Ordinance are to the extent of such conflict hereby repealed, the remainder of such Ordinance shall continue in full force and effect.

Section 4. That if any provision of this Ordinance shall be held to be invalid or unconstitutional, the remainder of such Ordinance shall continue in full force and effect the same as is such.

Section 5. That it is the intention of the City Council and is hereby ordained that the provisions of this Ordinance shall become and be a part of the Code of Ordinances of the City of Marlin, Texas, and that sections of this Ordinance may be renumbered or relettered to accomplish such intentions.

Section 6. That it is hereby officially found and determined that the meeting at which this Ordinance is passed is open to the public as required by law and that the public notice of time, place and purpose of said meeting was given as required.

Section 7. This Ordinance shall be in full force and effect from and after its passage and it is so ordained.
